# **SECTION 4: First aid measures**

#### 4.1. Description of first aid measures

#### **General information**

Move victim out of danger zone and lay down.

#### After inhalation

In case of inhalation of decomposition products, take the affected person into the fresh air and sit him quietly. Remove casualty to fresh air and keep warm and at rest.

#### **SECTION 5: Firefighting measures**

#### 5.1. Extinguishing media




